ORDER:

1. In the government order read above the Government issued orders approving the proposal of the Director of Archaeology for declaring Pochlavudayar Inscription and Bed at Secvalaperi Vill-Palayamkottai Taluk, Tirunelveli Kattabomman District as Protected Monument and the Notification for publication in the Tamil Nadu Government Gazette inviting visitation and survey of the said monument as a protected and its remains under sub-section (1) of Section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966 (Tamil Nadu Act of 1966). No objection or demurral has been received either from the Government or by the Director of Archaeology, Madras. The Director of Archaeology has therefore requested the Government to issue Notification declaring the aforesaid monument as a 'Protected Monument' under sub-section (3) of Section 3 of the said Act and has submitted a draft Notification accordingly. The Government approve the proposal of the Director of Archaeology and approve the draft Notification submitted by him.

2. The Notification annexed to this order will be published in the Tamil Nadu Government Gazette. The Works Manager, Government Press, Madras is requested to supply 5 copies of the Gazette Notification as published in the Tamil Nadu Government Gazette to the Government and to the Director of Archaeology.
