ORDER: - In the Government Order read above, a notification was published inviting objections and suggestions in regard to the proposal for declaring the Siva Temple at Ayyapatti Village, Madurai District as a protected monument as required under sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical monuments and Archaeological ~~and~~ Sites and Remains Act, 1966. No objection or suggestion has been received either by the Government or by the Director of Archaeology, Madras. The Director of Archaeology has therefore proposed a Notification, declaring the aforesaid monument as a " Protected monument" under sub-section 3 of Section (1) of the said Act may be issued and has submitted a draft notification accordingly. The Government approve the proposal of the Director of Archaeology.
