

Order

In the Government of Tamil Nadu, the Government is pleased to order approving the proposal of the Director of Archaeology declaring the Jalleeswarar temple in Nallikulam village, Arakonam Taluk, North Arcot District as a protected monument and the notification for publication in the Tamil Nadu Government Gazette inviting objections and suggestions in regard to the proposal excluding the above monument as a protected monument under sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological sites and remains Act, 1956, (Tamil Nadu Act 25 of 1956). No objection or suggestion has been received either by the Government or by the Director of Archaeology, U.P.O. The Director of Archaeology has therefore requested the Government to publish the said notification as a protected monument under sub-section (3) of section 3 of the said Act and is submitted to the Director of Archaeology. The Government has directed the Director of Archaeology to do so as is fit and proper.

2. The Notification annexed to this Order will be in the Tamil language at least. The Director of Archaeology, Government of Tamil Nadu is requested to supply 5 copies of the said Notification to be published in the Tamil Nadu Government Gazette to the Government after the end of every month.
