ORDER:

In the G.O. read above, a notification was published inviting objections and suggestions in regard to the proposal for declaring Sivan Koil at Kandamangalam village, Villupuram Taluk, South Arcot District as a protected monument as required under sub-section (1) of Section 3 of the TamilNadu Ancient and Historical Monuments and Archaeological Sites and Remains Act 1966. No objection or suggestion has been received either by the Government or by the Director of Archaeology, Madras. The Director of Archaeology, (in charge) has therefore requested the Government to issue Notification declaring the aforesaid monument as a 'protected monument' under sub-section 3 of Section 3 of the said Act and has submitted a draft notification accordingly. The Government approve the proposal of the Director of Archaeology (in charge) and approve the draft notification submitted by him.

2. The notification annexed to this order will be published in the TamilNadu Government Gazette. The Works Manager, Government Press, Madras is requested to supply 5 copies of the Gazette Notification as published in the TamilNadu Government Gazette to the Government and to the Director of Archaeology, Madras.


