ORDER:

An ancient Historical Site locally known as "Maligaimedu" is situated in S.No.200/1 of the Ulkottai Village, Udayarpalayam Taluk, Trichy District in the puramboke land. This place is believed to have been a place where the ancient capital city of Rajendra Chola had once stood. The formation of ground level at Maligaimedu and the ancient bricks reveals that it might have belonged to the medieval period, and the place a part of the palace of Medieval Chola Kings. The Director of Archaeology has therefore requested that this ancient site may be protected as a monument under the Tamil Nadu Ancient Historical and Archaeological Sites and Remains Act. 1966.

2. The Director of Archaeology has accordingly submitted a draft notification under Section 3(3) of the said Act. The Government accept the suggestion of the Director of Archaeology and approve the draft notification submitted by him.

3. The notification appended to this order will be published in the Tamil Nadu Government Gazette. The Director of Archaeology is requested to affix the notification in a conspicuous place near the monument.

4. The Director of Stationery and Printing Madras-1, is requested to publish the above notification in the next issue of the Tamil Nadu Government Gazette and supply ten copies of the notification each to the Government and the Director of Archaeology.

Objections and suggestions, if any, should be addressed to the Secretary to the Government of Tamil Nadu, Education Department, Fort St. George, Madras -600 009.
