ORDER:

In the Government Order read above, the Government have issued orders approving the proposal for declaring Rock Art, Tamil Brahmi Inscriptions, Jain Beds, Cave Temple and Vattezhuththu Inscriptions in Thirumalai Village, Sivagangai Taluk, Sivagangai District, as a protected monument and published a Notification in the Tamil Nadu Government Gazette as required under sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966 (Tamil Nadu Act 25 of 1966). No objection or suggestion has been received by the Government. The Government have decided to issue Notification declaring the above said monument as a 'protected monument' under sub-section (3) of section 3 of the said Act.
