Order:

In the Government Order read above, the Government issued orders approving the proposal of the Director of Archaeology for declaring the rock pool and inscription in rock body at Periyaperipatti village, Omalur taluk, Salem District as a protected monument and the notification for publication in the Tamil Nadu Government Gazette inviting objections and suggestions in regard to the proposal for declaring the above monument as a protected one as required under sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1965, (Tamil Nadu Act 2, of 1965). No objection or suggestion has been received either by the Government or by the Director of Archaeology, Dr. ... . The Director of Archaeology has therefore requested the Government to issue a notification declaring the present monument as a "protected monument" under sub-section (3) of section 3 of the said Act. He has submitted a draft notification accordingly. The Government approves the proposal of the Director of Archaeology and accepts the draft notification submitted by him.

2. The notification annexed to this order will be published in the Tamil Nadu Government Gazette. The Works Manager, Government Press is requested to supply 5 copies of the gazette notification as published in the Tamil Nadu Government Gazette to the Government and to the Director of Archaeology, Madras.



**ORDER:**

In the Government Order first read above, orders were issued declaring the Rock Pool and inscriptions in rock bed at Periyayripatti Village, Omalur Taluk, Salem District as a protected monument under Sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act 1966 (Tamil Nadu Act 25 of 1966). It was also ordered an extent of 0.81 acres adjoining the Rock Pool and inscription in rock bed at Periyayripatti Village as a 'Prohibited Area' under Rule 32 of Chapter VII of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Rules 1971.

2. In the Government Order second read above, final Notification was issued under sub-section (3) of Section 3 of the said Act to declare the Rock Pool and rock bed inscriptions at Periyayripatti Village, Omalur Taluk, Salem District as a protected monument. However in the Government Order, the second Notification and the second Schedule declaring the area adjoining the monument as Prohibited area were not mentioned. The Director of Archaeology in his letter third read above has therefore requested the Government to issue Amendment to the Government Order second read above declaring the Area adjoining the monuments as prohibited area. Now it is therefore proposed to issue a Notification under rule 33 of Chapter VII of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Rules 1971 to declare the area adjoining the monument as Prohibited area.


