ORDER

In G.O.Ms.No.702, Education, dated 5.5.75, orders were issued notifying the intention of the Government for taking over Swasthika Well Tiruvellarai, Tiruchirapalli District, Agastheeswarar Arunachaleswarar Twin Temple, Kizhayur village, Tiruchirapalli District, Pillai Choultry Selkvazhi Mangalam village, Sripurumbadur taluk, Chingleput District and Kattabomman Fort, Panchalankurichi, Tirunelveli District for protection-preservation and maintenance by the Department of Archaeology. Objections and suggestions were invited for the proposed taking over. The Director of Archaeology has reported that no objections have been received from the public to taking over the above monuments by the Department of Archaeology. The Government therefore confirm the order issued in the G.O.cited.
