ORDER:-

Accordingly Notification under sub-section (1) of section (3) of the said Act was published in para II section 2 of Tamil Nadu Government Gazette dated 19.9.90. No objection or suggestion has been received either by the Government or by the Director of Archaeology, Madras. The Director of Archaeology has therefore requested the Government to issue Notification declaring the aforesaid monument as 'protected monuments' under sub-section (3) of Section 3 of the said act and has submitted a draft notification accordingly. The Government approve the proposal of the Director of Archaeology and approve the draft notification submitted by him.
