In the Government Order read above the Government issued orders involving the proposal of the Director of Archaeology (in-charge) declaring the rock paintings at Koolvalai Village, Thirukkovilur Taluk, South Arcot District as a protected monument and the application for publication in the Tamil Nadu Government Gazette, taking objections and suggestions in regard to the proposal for declaring the rock paintings at Koolvalai Village, Thirukkovilur Taluk, South Arcot District as a "protected monument," as required under subsection (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, (Tamil Nadu Act 75 of 1956). No objection or suggestion has been received either by the Government or by the Director of Archaeology, Madras. The Director of Archaeology has therefore requested the Government to issue Notification Declaring the said monument as a "protected monument" under subsection 3 of the said act and has submitted a draft notification accordingly. Government approve the proposal of the Director of Archaeology to issue the draft notification submitted by him.
