ORDER:

In the G.O. read above, a notification was published among other things inviting objections and suggestions in regard to the proposal for declaring the Siva Temple at Sivankoodal Village, Sriperumbendur Taluk, Chengalpattu District as a protected monument as required under sub section (I) of Section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act 1966. No objection or suggestion has been received either by the Government or by the Director of Archaeology, Madras. The Director of Archaeology has therefore requested the Government to issue Notification declaring the aforesaid monument as a "Protected monument" under sub-Section 3 of Section 3 of the said Act and has submitted a draft notification accordingly. The Government approve the proposal of the Director of inchaeology and approve the draft Notification submitted by him.
