ORDER:

In the letter read above the Director of Archaeology has submitted to the Government for declaring the Kanja Sahib Tomb, Sholingar, North Arcot District as protected monuments under the control of the Department of Archaeology by publishing a Notification in the Tamil Nadu Government Gazette under sub-section (3) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act 1966 (Tamil Nadu Act 25 of 1966) Prior to declaring the above monument as above Notification under sub-section (1) of section 3 of the said Act has to be published in the Tamil Nadu Government Gazette.

2. The Government accept the proposal of the Director of Archaeology, Madras and accordingly the Notification appended to this order will be published in the Tamil Nadu Government Gazette.

3. The Works Manager, Government Central Press, Madras-79 is requested to publish the Notification appended to this order in the next issue of the Tamil Nadu Government Gazette and send 16 copies of the Gazette containing the Notification to the Director of Archaeology, Madras and to the Secretary to Government, Tamil Development-Culture Department, Madras-9 and 16 copies of the same to the District Revenue Officer, North Arcot District, Vellore.

The Director of Archaeology, Government of Tamil Nadu, Madras is requested to affix the Notification in a conspicuous place near the monument as requested by sub-section (1) of Section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act 1966. (Tamil Nadu Act 25 of 1966)

5. Four copies of the Notification in Tamil are forwarded to the Director of Information and Public Relations, Madras-9 and he is requested to arrange for their publication in the two daily newspapers (in Tamil) circulation in the locality as ordered above.

6. The following certificate is issued in respect of the publication of the Notification:

- (i) Sufficient funds are available to meet the cost of the advertisement.
- (ii) the bill for the advertisement will be paid within 30 days of its receipt and
- (iii) no previous advertisement bill is pending for settlement for more than one month.

7. The Director of Archaeology, Madras is requested to send a report to the Government so as to confirm the Notification under sub-section (3) of section 3 of the said Act at the appropriate time.

NOTIFICATION.

WHEREAS the Government of Tamil Nadu are of the opinion that the ancient monument specified in the Schedule below requires protection under the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966 (Tamil Nadu Act 25 of 1966).

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 3 of the said Act, the Governor of Tamil Nadu hereby gives notice of his intention to declare the ancient monument specified in the Schedule below to be a protected monument.

ANY PERSON interested in the ancient monument aforesaid may, within two months after the publication of the Notification in the Tamil Nadu Government Gazette, object to the declaration of the said ancient monument to be a protected monument. Any objection which may be received from any person before the expiry of the said period of two months will be considered by the Government of Tamil Nadu. Objection, if any, should be addressed to the Secretary to Government, Tamil Development-Culture Department, Madras-600 009.


